### **Course Description**

This course involves a survey of the issues around the world of refugees and how the church can minister to them on their journey and upon arrival in their new homes. Issues related to migration and how immigrants can be reached for Christ will also be examined. An examination will also be made of internationals, especially students, who live around us and how we can be more effective in ministering to them.

By the end of this course, students will be able to:

- 1. Identify and describe the issues and problems faced by refugees, immigrants, and internationals.
- 2. Understand and design effective ministries to refugees, immigrants, and internationals.
- 3. Value the place that refugees, immigrants, and internationals play in our society and the role churches and ministries have in ministering the love of Christ to these individuals.
- 4. Apply principals of ministry to refugees, immigrants, and internationals in ways that will lead churches and other ministries to effective ministry.

## **Course Teaching Methodology**

A variety of teaching methods will be utilized such as class presentations by the professor using PowerPoint and handouts. Other teaching methods include small and large group discussion, multi-media presentations, utilization of missions related web sites, and other communication mediums. Students will be exposed to individuals in the target group and will learn from that interaction.

## **Course Requirements**

- 1. **Unit One**. Once each student has completed the registration procedures and had cleared the business office, he or she will be automatically enrolled in the Blackboard portion of the course. The class will begin on Jan 21. The first thing each student should do is go through Unit 1. This will explain course procedures. This unit should be completed by Sat. Jan. 26.
- 2. **Blackboard Units**. Students should proceed through the learning units in numerical order beginning with Unit 1. New units with be released several at a time so students should not expect to work ahead too far. Units will be due on each Saturday at 11:59 PM. All units must be completed along with required readings. At the end of each section of a unit students will indicate completion of that section of the unit by clicking on the "Reviewed" button. PLEASE DO NOT FORGET TO MARK AS REVIEWED AS YOU GOT THOUGH THE DIFFERENT PARTS OF EACH UNIT. Orderly completion of the weekly units along with attention to the specific assignments given in this syllabus will keep the student on track for successful completion of the course. Most units will contain quizzes. Quizzes CANNOT be taken late. If you miss a quiz you will not get credit for that quiz. The two lowest quiz grades will be dropped. Quizzes can be taken at least twice and you can access any materials in completing the quizzes. A second attempt on a quiz CANNOT add more than 50 points to your quiz score, so students should attempt to answer all questions on the first attempt. For example, if you make 40 on the first attempt, even if you get all answers correct on the second attempt, your score on the second attempt would be 90.
- 3. **Textbook Reading**. Read both textbooks as assigned. Be prepared to show comprehension of the texts through class discussions and through reading quizzes. Also read other assigned reading given during the semester.
- 4. "The Good Lie." Watch the movie, "The Good Lie." In a discussion forum in Unit 6 due on Mar. 2 discuss the movie and implications for churches and other organizations doing ministry to refugees settling in a new country. Your discussion should contain at least six significant paragraphs.
- 5. Extra Book Discussion. Choose one book from the bibliography to read and discuss on the appropriate Blackboard discussion board. You should have at least 6 substantial paragraphs in your discussion. React to the discussions of all others in the class. Due on Mar. 30. The

reflections on the discussion of others is due on April 2.

- 6. **Volunteer Experience**. Spend five hours in volunteer service at a church, ministry, or organization ministering to, or working with, refugees, immigrants, or internationals. As much as possible the hours should be spent working with one or more of these groups. Discuss this experience in the appropriate Blackboard Discussion Forum. The discussion should be approximately four paragraphs long. The discussion is due on Apr. 3.
- 7. **Ministry Study**. Study a church, ministry, or organization ministering to, or working with, refugees, immigrants, or internationals. Submit a 2-3 page summary (8-10 substantial paragraphs) of that ministry in the Blackboard Discussion Forum. Respond to the posts of your fellow students. Due on Apr. 20.
- 8. **Interviews Project**. Locate and interview three individuals. Find someone for each of the categories of refugee, immigrant, and international. Ask the individuals about issues related to how they came to their current country, what were the conditions in their previous homeland, what were their experiences in moving to their current home, what were their greatest needs when resettling, how they relate to others from their homeland, how they relate to the people and culture of their new home, and what their future plans are as to resettlement. Include several other topics in your interview. Present a 1 page summary of each interview. Also present a 1-2 page reflection on implications for ministry based on your three interviews. This is a single reflection paper and NOT a reflection paper for each interview. Due on May 4 during Unit 14 in the appropriate discussion board. Respond to other presentations by May 11.
- 9. **Reflection Discussion**. A part of the final exam will be a discussion question reflecting on your learning experiences in this class. Your discussion should be at least six significant paragraphs. Reflect on new materials, concepts, and ministry opportunities that were covered. Reflect on your experiences with refugees, immigrants, or internationals that you had during the semester. Reflect on your interactions with your fellow students. Finally, discuss some possible ways that you can implement ministry initiatives with refugees, immigrants, and internationals and how you might encourage others to engage in similar kinds of ministry. Due on May 16 as a part of the final exam..
