Gezer Finds Released



The summer 2016 dig season in the Tel Gezer water tunnel was the most productive to date, uncovering artifacts and structures that establish the system as one of the oldest and most advanced in Israel.

Beneath the Canannite Gate, which was built during the same period as the water system, a probe located two parallel walls. Pottery around these east-west walls indicates that the water system may date to the Middle Bronze Age II (2000-1750 BC), close to the time of Abraham and the Jebusite water system in Jerusalem.

Registration Opens October 31

Registration for January and Spring 2017 will open at 8:00 AM Central Time on Monday, October 31, 2016 and close at 4:00 PM on Monday, November 14. The schedule is available online.

If you are NOT taking a course in the January miniterm or spring semester, such as students in Program Proficiency, Writing Candidacy, or Inactive Status, you do NOT have to register. The ReDOC office will register students for program statuses.

Before October 31, be sure to check your account through SelfServe. Your balance must be \$0 (no STOP on your account) for you to register. If you have a STOP, work with the office that placed it to get it removed so that you can register by the 4:00 PM November 14 deadline.

Students who cannot be registered by the deadline will incur a \$200 late registration fee. Tuition for semester courses is not due until Friday, January 13, so register as soon as possible.

Tuition for January courses is due the Friday before the course begins.

If you submit a research proposal by the November 1 deadline, you should register for RDOC9303 Prospectus Development in the January miniterm. If your proposal is not approved by the December 16 deadline, we will drop you from the course at no charge.

An IRB request <u>and</u> a pdf of a prospectus for research using human subjects must be **submitted to the guidance committee chair**, who must forward them to redocsec@ nobts.edu, indicating permission to proceed, no later than

one month prior to the meeting at which the prospectus will be considered. See the Program Materials page for the form and details.

A prospectus to be considered by ReDOC must be reviewed by your guidance committee and **9 copies** submitted through your chairperson to the Office of Research Doctoral Programs no later than one week before the scheduled ReDOC meeting. Prospectuses for research involving human subjects must be received one month before the meeting.

Likewise, matters such as directed study proposals and requests to take courses at other institutions must be submitted one week before the ReDOC meeting at which they will be considered.

Also e-mail a **pdf** of the prospectus or directed study proposal to phd@nobts.edu. Do submit a hard copy of the directed study approval page.

Please keep in mind that final approval of your prospectus is granted by your doctoral guidance committee after you make any revisions your committee deems appropriate in light of feedback from ReDOC.

If you are required to go through the Institutional Review Board approval process for research with human subjects, your committee cannot approve your prospectus until the IRB assesses the risk to and protection of the participants.



NOTE: If you think your guidance committee has approved your prospectus but you have not seen your approval in the *ReDOC News*, please let us know.

Research Proposals Due by November 1

Students registering for the January 2-6, 2017 Prospectus Development course must submit 4 copies of the research proposal to the guidance committee chair by November 1, 2016. Chairs will enlist two additional division faculty to read the proposal and give feedback, and committees have until December 16 to work with students on revisions and forward 2 copies of the proposal and a Research Proposal Report form to the ReDOC office.

Newcombe Fellowship: November 15 Deadline

The <u>Charlotte W. Newcombe Doctoral Dissertation</u> <u>Fellowships</u> support the final year of dissertation research for PhD candidates in the humanities and social sciences. Proposals should have religious or ethical values as a central concern and be relevant to the solution of contemporary religious, cultural, or human rights questions. The stipend is \$25,000 for a 12-month period of dissertation writing, with the expectation the dissertation will be completed between April 1 and August 31, 2018.

Proposal submission deadline: **November 15, 2016**, 11:59 p.m. Eastern Time.

EHS Emerging Scholars Grant

In keeping with a commitment to cultivate scholars in the field of homiletics, the Evangelical Homiletics Society has established an Emerging Scholars Grant of \$2,000 plus registration fees and meals to attend the annual EHS conference. The grant competition is open to all PhD students who are Associate Members of EHS (fee: \$25/year).

- To enter, submit a paper of 15,000 to 20,000 words focusing on a relevant issue in homiletics.
- Papers must follow the EHS style guide.
- The EHS jury will evaluate papers based on relevance to the teaching of biblical preaching and the EHS confessional statement.
- The winner will be recognized at the annual conference and may present the research at the conference and/or have the article published in *JEHS*.

Submission deadline: May 31



George Weigel is a Distinguished Senior Fellow of the Ethics and Public Policy Center in Washington, DC, where he holds the William E. Simon Chair in Catholic Studies. As president of the Ethics Center, he led a wide-ranging research program on foreign and domestic policy issues (1989-1996). As a Senior Fellow, he began publishing his major study of Pope John Paul II, which appeared in two volumes: Witness to Hope (Harper, 1999) and The End and the Beginning: Pope John Paul II—The Victory of Freedom, the Last Years, the Legacy (Doubleday, 2010). Mr. Weigel also is the author of The Cube and the Cathedral: Europe, America, and Politics without God (Basic, 2006); Evangelical Catholicism: Deep Reform in the 21st-Century Church (Basic, 2013); and Letters to a Young Catholic (Basic, 2015). He is the Senior Vatican Analyst for NBC News and writes the weekly column "The Catholic Difference," which is syndicated to 60 newspapers.
