 - Biblical Interpretation seems to be doing well.
 - Teaching and preaching abilities.
 - What we have done this semester and last (terms 183 and 191) show improvement. Keep doing what we are doing.
- 2. If not obvious from the rubric or other juries, please note specific **weaknesses to be improved** in the degree program as a whole (and/or curriculum) found by the jury related to SLOs.
 - Consistent teaching at prisons is a concern.
 - Consistency in grading; deal with grade inflation.
 - Have more than one scorer for rubrics to provide perspective.
 - *Student Satisfaction Survey*, questions 39 & 40 regarding worship: How are students defining worship? (Analyze wording and revise as necessary.)
 - Qualifications and training of adjuncts at extension centers.
- 3. Please note any **recommended or proposed curricular improvements** needed related to SLOs.
 - Revised curriculum; no changes needed.
 - Allow new curriculum to be established a year or two before recommending any changes.

- Suggest elaborating our SLOs to ensure are articulated as outcomes.

- Transfer students (ETS, Intro to Ministry, PSD).
- 4. Please note any **recommendations or improvements for the process.** (Revision of rubric, reconsideration of SLOs, reconsideration of artifact used, etc.)
 - Ensure tests given are appropriate.
 - Prison Facilities: monitor prisons, communicate the outcomes, check on prison consistency in teaching and grading.
 - Reconsider artifacts.
 - Revise rubrics to coincide with the curriculum (especially oral presentation rubric).
 - Evaluate use of jury once the new majors are in place.
 - Adapt standardized rubrics for all courses. In doing so, can eliminate juries.
