REFLECTION ON RESULT FOR STUDENT LEARNING OUTCOME 1:

- Following the MDiv Revision (August 9, 2023), the MTS was revised to include the MDiv core. The degree, however, is still a knowledge-based degree that emphasizes T&H and Biblical Studies courses.
- The program has maintained consistent, viable enrollment numbers.

- Although the data from the Summative Assessment Exam indicates that two disciplines could be targeted for improvement, the jury chose an action plan to improve outcomes in Baptist Heritage because it showed low scores more consistently. Additionally, Baptist Heritage is newer to the degree program, added after the MDiv Revision, and has, therefore, not yet been assessed.
- The action plan that most directly addresses the student improvement regarding Program Outcome 1 encourages teachers of Baptist Heritage to highlight what it means to be Baptist, what distinguishes Baptists, and why being Baptist matters. The jury thinks that retention of knowledge regarding Baptist distinctives best reflects student development in line with the mission of NOBTS. As such, professors should be encouraged to emphasize what it means to be Baptist and why it matters, while at the same time not neglecting historical facts and figures, which are so important for students to know in order to stand in the Baptist tradition.
- The indirect measure is new to the MTS program assessment since the 2023 assessment of the degree program. Data is now available to set a baseline metric. The jury expects the action plans to have a positive effect on the indirect measure.

Student Learning Outcome #2: Students will communicate their understanding of cultural and historical contexts.

Dr. Riley will instruct the Office of Distance Learning, under the direction of Dr. Browning, to work with the prisons and those teaching ethics in the prisons to secure embedded assignments at the end of the semesters it is taught and in accordance with prison policy.

REFLECTION ON RESULT FOR STUDENT LEARNING OUTCOME 2:

- Overall, the MTS students exceeded the benchmark set for the Embedded Assignment. Even so, students in online sections consistently underperformed (SP 24: 2.87 & FA 24: 2.30). Because ethics is a discipline in which students will engage culture, communicating a Christian moral position contextually, the jury thought it important to encourage those who teach ethics to instruct students of communicating ethical content accurately, faithfully, and with Christian character.
- Because the MTS course Assessment Map and the Christian Ethics Canvas shell changed after the degree program revisions, Dr. Riley will look closely to ensure that the Canvas shell for Christian Ethics reflects accurately the changes to the Degree program.

REFLECTION ON RESULT FOR STUDENT LEARNING OUTCOME 3:

- The Embedded Assignment for Discipleship & Spiritual Formation is not housed in the T&H or Biblical Studies divisions but appropriately measures a demonstration of personal and spiritual maturity. All MTS students are required to take Discipleship and Spiritual Formation, which houses the embedded assignment.
- The first two semesters of data for the embedded assignment fell short of the benchmark. A previous assessment led the Christian Education faculty to provide examples of what a quality discipleship map entails. After providing examples, the average per semester for the assignment improved markedly.
- The jury discussed how the T&H and Biblical Studies courses in the degree program might foster spiritual and personal growth in MTS students.
